AN ORDINANCE REPEALING SECTION 220.05(a) OF THE CODIFIED ORDINANCES OF THE VILLAGE OF SOUTH RUSSELL, ADOPTING NEW SECTION 220.05(a) OF THE CODIFIED ORDINANCES OF THE VILLAGE OF SOUTH RUSSELL AND DECLARING AN EMERGENCY.

WHEREAS, Council desires to repeal Section 220.05 of the Codified Ordinances of the Village of South Russell to ensure consistency with the Ohio Revised Code and Section 260.02 as to how a council member is appointed to the Planning Commission, and to reformat the numbering of committees.

NOW, THEREFORE, be it ordained by the Council of the Village of South Russell that:

**SECTION 1.** Section 220.05(a) of the Codified Ordinances of South Russell Village is hereby repealed.

**SECTION 2.** Section 220.05(a) of the Codified Ordinances of South Russell Village is hereby adopted and shall read in its entirety as follows:

- "(a) Appointment of Committees. The following standing committees, consisting of two members each, are hereby authorized. Appointment of members to such committees shall be made by the Mayor and approved by Council.
  - (1) Building Department Committee.
  - (2) Finance Committee.
  - (3) Human Resources Committee.
  - (4) Properties Committee.
  - (5) Public Utilities Committee.
  - (6) Safety Committee.
  - (7) Streets Committee.

The Mayor, with Council's approval, or Council may appoint such special or ad hoc committees as are deemed necessary, provided that matters referred to or pending before a standing committee may not, without consent of its members, be referred to or considered by a special committee."

<u>SECTION 3</u>. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees on or after December

2, 1975, that resulted in formal actions, were in meetings open to the public in compliance with all legal requirements, including Section 121.22, Ohio Revised Code.

SECTION 4. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety, and welfare and for the further reason that this Ordinance must be immediately effective to ensure consistency with the Ohio Revised Code and the Codified Ordinances of the Village; wherefore, provided it receives the affirmative vote of at least two-thirds (2/3) of all members elected to Council, this Ordinance shall be in full force and effect immediately upon its passage.
