A RESOLUTION OF APPRECIATION FOR CYNTHIA NAIRN

WHEREAS Cynthia Nairn served on the Cemetery Committee beginning in 2008 and was instrumental in the South Russell Village Cemetery's planning and development. Subsequently, she was appointed in 2016 to serve as a member of Council and thereafter elected for a term commencing from 2018 to 2021; and

WHEREAS, during her time with Council, Cynthia Nairn served as the Chair and/or member of the Building, Finance, Human Resources, Properties, Park, Public Utilities, and Safety Committees. Additionally, she applied her editing skills in the review of Council and committee minutes as well as the Village newsletters; and

WHEREAS, during her time with Council, the Village was able to increase revenue to expand its Road Program; construct a playground at the park; rebuild the Lake Louise Drive Bridge; begin systematic storm water mitigation by securing two 319 grants totaling over \$600,000 to build a stream enhancement south of Village Hall, create wetlands in the park to reduce water flowing into Country Estates, and control water flowing into Manor Brook/Whitetail.

WHEREAS Cynthia Nairn acted in a professional, conscientious, and dedicated manner for the good of the Village residents while serving as Council Member for the Village of South Russell; and

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of South Russell, County of Geauga, State of Ohio, that:


SECTION 1. The Mayor and Council of the Village of South Russell, Ohio express their sincere appreciation to Cynthia Nairn for service as a Village Council Member and for her dedication to the community.

SECTION 2. The Mayor and Council desire this commendation of Cynthia Nairn to become a permanent part of the records of the Village of South Russell.

SECTION 3. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees on or after November 25, 1975, that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. This Resolution shall be effective at the earliest time allowed by law.


