AN ORDINANCE REPEALING SECTION 220.01(a) OF THE CODIFIED ORDINANCES OF THE VILLAGE OF SOUTH RUSSELL, ENACTING NEW SECTION 220.01(a) OF THE CODIFIED ORDINANCES OF THE VILLAGE OF SOUTH RUSSELL, AND DECLARING AN EMERGENCY.

WHEREAS, Council desires to amend Section 220.01(a) of the Codified Ordinances of the Village of South Russell to change the time for all regular meetings of Council from 7:30 p.m. to 7:00 p.m.

NOW, THEREFORE, be it ordained by the Council of the Village of South Russell that:

SECTION 1. Section 220.01(a) of the Codified Ordinances of the Village of South Russell is hereby repealed.

SECTION 2. Section 220.01(a) of the Codified Ordinances of the Village of South Russell is hereby enacted to read in its entirety as follows:

“(a) Regular Meetings. Council shall meet in regular session in the Council Chambers at Village Hall, 5205 Chillicothe Road, South Russell, Ohio at 7:00 p.m. on the second and fourth Mondays of each month. During the months of June, July, August and December Council shall meet in regular session on the second Monday only. Should any holiday fall upon the date for a regular meeting, Council shall appoint another date within the same month in lieu thereof.”

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees on or after December 2, 1975, that resulted in formal actions, were in meetings open to the public in compliance with all legal requirements, including Section 121.22, Ohio Revised Code.

SECTION 4. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety, and welfare and for the further reason that this Ordinance must be immediately effective so that Council may immediately implement its new meeting time; wherefore, provided it receives the affirmative vote of at least two-thirds (2/3) of all members elected to Council, this Ordinance shall be in full force and effect immediately upon its passage.
