ORDINANCE APPROVING THE MEMORANDUM OF UNDERSTANDING BETWEEN THE VILLAGE OF SOUTH RUSSELL AND THE GEAUGA COUNTY ENGINEER AND/OR BOARD OF COMMISSIONERS FOR THE RESURFACING OF WASHINGTON STREET AND DECLARING AN EMERGENCY.

WHEREAS, the Village of South Russell desires to enter into a Memorandum of Understanding with the Geauga County Engineer and/or the Geauga County Board of Commissioners ("County") whereby it agrees to fund the portion of the County's Washington Street improvement that extends into the Village of South Russell pursuant to the terms and conditions of the Memorandum of Understanding, a copy of which is attached hereto as **EXHIBIT A**.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of South Russell, Geauga County, Ohio that:

SECTION 1. The Memorandum of Understanding between the Village of South Russell and the County Board is hereby approved pursuant to the terms and conditions in the Memorandum of Understanding attached hereto as **EXHIBIT** A.

SECTION 2. The Mayor is hereby authorized to execute the Memorandum of Understanding for the Village of South Russell.

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees on or after December 2, 1975, that resulted in formal actions, were in meetings open to the public in compliance with all legal requirements, including Section 121.22, Ohio Revised Code.

SECTION 4. That this Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health and safety of the inhabitants of the Village and for the further reason that the County has requested that this be effective immediately; wherefore provided it receives the affirmative vote of at least two-thirds (2/3) of all members elected to Council, this Ordinance shall be in full force and effect from and immediately upon its passage by this Council and approval by the Mayor.
