## ORDINANCE AUTHORIZING THE SALE OF VILLAGE PERSONAL PROPERTY NOT NEEDED BY THE VILLAGE AND **DECLARING AN EMERGENCY**

WHEREAS, the Village is desirous of selling certain village-owned property which is no longer used.

NOW THEREFORE BE IT ORDAINED by the Council of the Village of South Russell, Geauga County, Ohio:

SECTION 1. The Village of South Russell is hereby authorized to sell the property which is no longer needed for Village purposes as set forth on the attached Exhibit A.

**SECTION 2.** The Mayor of the Village and Fiscal Officer are hereby authorized to execute any and all documents pertaining to the requirements set forth in said Act on behalf of the Village.

**SECTION 2.** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees on or after December 2, 1975, that resulted in formal actions, were in meetings open to the public in compliance with all legal requirements, including Section 121.22, Ohio Revised Code.

**SECTION 3.** This Ordinance is declared to be an emergency measure, the emergency being the intent to sell personal property not needed for public use within 30 days and for the public health, peace and welfare of the Village of South Russell. Wherefore this Ordinance shall take effect and be in force immediately upon its adoption.
