ORDINANCE AMENDING ORDINANCE 2022-____ BY AMENDING PAY RANGE FOR PART TIME BUILDING AND ZONING INSPECTOR OF THE VILLAGE OF SOUTH RUSSELL AND DECLARING AN EMERGENCY.

WHEREAS, Council desires to amend the Pay Schedules as enacted in Ordinance No. 2022-____ by increasing both the minimum and maximum amounts for the position listed in number 18 of the Pay Schedules for part time Building and Zoning Inspector;

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of South Russell, Geauga County, Ohio that:

SECTION 1. The Pay Schedules for the following officers and employees of the Village of South Russell shall be as follows:

SECTION 2. This Ordinance increases the minimum and maximum amounts for the position of part-time Patrol Officer of number 18 listed on the Pay Schedules only the Pay Schedules as enacted in Section 1 of Ordinance No. 2022-___. All other sections of Ordinance No. 2022-___. remain in effect.

SECTION 3. Any position and pay range previously adopted which is not in conflict with this Ordinance and in effect as of the date of this Ordinance remains in full force and effect.

SECTION 4. Pay rates for new employees and pay rates for existing employees who change positions will be established by the Mayor within the Pay Schedules in effect at the time. Pay rate adjustments within the Pay Schedules will be established by motion and voted thereon by a majority vote of Council.

SECTION 5. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees on or after December 2, 1975, that resulted in formal actions, were in meetings open to the public in compliance with all legal requirements, including Section 121.22, Ohio Revised Code.

SECTION 6. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety, and welfare and for the further reason that this Ordinance must be immediately effective so that the Village's Pay Schedules are commensurate with neighboring jurisdictions for similarly situated positions; wherefore, provided it receives the affirmative vote of at least two-thirds (2/3) of all members elected to Council, this Ordinance shall be in full force and effect immediately upon its passage.
