AN ORDINANCE AMENDING SECTION 220.01 OF THE CODIFIED ORDINANCES OF THE VILLAGE OF SOUTH RUSSELL AND DECLARING AN EMERGENCY.

WHEREAS, Council desires to amend Section 220.01 of the Codified Ordinances of the Village of South Russell to reflect the publication of summaries of ordinances and resolutions in a newspaper of general circulation in the Village of South Russel, consistent with Ohio law.

NOW, **THEREFORE**, be it ordained by the Council of the Village of South Russell that:

SECTION 1. Section 220.01 of the Codified Ordinances of the Village of South Russell currently reads as follows:

"220.01 POSTING PLACES.

- "(a) Council may, at its option, elect to post its ordinances and resolutions at five public places rather than have them published in a newspaper of general circulation.
- "(b) The public places are as follows:
 - (1) Village Hall, located at Bell Road and State Route 306;
 - (2) At the western extremity of the Village along Bell Road, on the south side of Bell Road on property owned by the Village;
 - (3) At the easterly extremity of the Village along Bell Road, on the south property line at the entrance of the property known as the Gun Club;
 - (4) On Washington Street, also known as State Route 422, at the entrance to the Rolling Ridge Subdivision; and
 - (5) On State Route 306 at its intersection with Sherbrook.
- "(c) The Street Commissioner shall cause the necessary devices for posting to be erected at the above five sites."

SECTION 2. Section 220.01 of the Codified Ordinances of the Village of South Russell is hereby deleted and amended to read in its entirety as follows:

"220.01 PUBLICATION.

"(a) A succinct summary of each ordinance or resolution and all statements, orders, proclamations, notices, and reports required by law or ordinance to be published shall be published in a newspaper of general circulation in the Village of South Russell once a week for two consecutive weeks or as provided in section 7.16 of the Ohio Revised Code. Proof of the publication and required circulation of any newspaper used as a medium of publication as provided by this section shall be made by affidavit of the proprietor of the newspaper and shall be filed with the Fiscal Officer.

- "(b) The publication shall contain notice that the complete text of each such ordinance or resolution may be obtained or viewed at the office of the Fiscal Officer, online on the Village's website, or at any other location designated by Council. The Village Solicitor shall review the summary of an ordinance or resolution published under this section prior to forwarding it to the Fiscal Officer for publication, to ensure that the summary is legally accurate and sufficient.
- "(c) Upon publication of a summary of an ordinance or resolution in accordance with this section, the Fiscal Officer shall supply a copy of the complete text of each such ordinance or resolution to any person, upon request, and may charge a reasonable fee, set by Council, for each copy supplied. The Fiscal Officer shall post a copy of the text at the office of the Fiscal Officer, online on the Village's website, and at every other location designated by Council."

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees on or after December 2, 1975, that resulted in formal actions, were in meetings open to the public in compliance with all legal requirements, including Section 121.22, Ohio Revised Code.

SECTION 4. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety, and welfare and for the further reason that this Ordinance must be immediately effective to ensure consistency with Ohio law; wherefore, provided it receives the affirmative vote of at least two-thirds (2/3) of all members elected to Council, this Ordinance shall be in full force and effect immediately upon its passage.
