A RESOLUTION APPROVING THE MASTER RAIN GARDENER AGREEMENT BETWEEN THE CHAGRIN RIVER WATERSHED PARTNERS, INC. AND THE VILLAGE OF SOUTH RUSSELL, AUTHORIZING THE MAYOR TO EXECUTE THE AGREEMENT ON BEHALF OF THE VILLAGE AND DECLARING AN EMERGENCY.

WHEREAS, the Chagrin River Watershed Partners, Inc. ("CRWP"), of which the Village of South Russell is a member in good-standing, offers the Master Rain Gardener program ("Program") through a partnership among CRWP, the Cuyahoga Soil and Water Conservation District, and Lake County Soil and Water Conservation District which, among other things, installs rain gardens in public places in an effort to reduce stormwater, improve water quality, and mitigate floodings; and

WHEREAS, the Village of South Russell desires to partner with CRWP to install a rain garden through the Program at the South Russell Village Park.

NOW THEREFORE BE IT RESOLVED, by the Council of the Village of South Russell, Geauga County, and State of Ohio, that:

SECTION 1. The Master Rain Gardener Agreement, which is attached hereto and incorporated herein by reference as Exhibit A, between CRWP and the Village of South Russell for CRWP to install a rain garden through the Program is hereby approved.

SECTION 2. The Mayor is hereby authorized to execute the Master Rain Gardener Agreement on behalf of the Village of South Russell.

SECTION 3. The effective date of the Master Rain Gardener Agreement is hereby retroactive to September 29, 2022.

SECTION 4. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council. and that all deliberations of this Council and of any of its committees on or after December 2, 1975, that resulted in formal actions, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety, and welfare and for the further reason to memorialize the terms and conditions of the already-installed rain garden in the South Russell Village Park; wherefore, wherefore, provided it receives the affirmative vote of at least two-thirds (2/3) of all members elected to Council, this Resolution shall be in full force and effect immediately upon its passage.

Chagrin River Watershed Partners, Inc. (CRWP) is partnering with the Village of South Russell (the Village) to install a rain garden at South Russell Village Park through the Master Rain Gardener (MRG) program. The MRG program is administered through a partnership between CRWP, Cuyahoga Soil and Water Conservation District, and Lake County Soil and Water Conservation District that consists of a 5-week course that trains residents and professionals to design, install, and maintain rain gardens. As a part of the program, public rain gardens are installed throughout the region by students and volunteers with the guidance of instructors during public rain garden field days. During a field day, the participants design and install a rain garden on site from start to finish in one day. Instructors plan the technical and logistical aspects of the rain garden ahead of time, including furnishing plant choices and working with the sites on rain garden design aspects. Participation in this project is an environmentally beneficial step that the Village wants to take to reduce stormwater, improve water quality, and mitigate flooding.

By signing this contract, the Village agrees to allow a rain garden to be installed at this site as part of the MRG program. The design and installation will be completed by CRWP in collaboration with its partners, MRG students, volunteers, and the Village and will follow guidelines outlined in the MRG program. CRWP will manage the rain garden funds, procure materials and services, and provide staff time, volunteers, and technical expertise to install the rain garden. At the Village's request, CRWP and partners can assist with identifying volunteers to assist with rain garden maintenance after installation. Obtaining a volunteer to maintain the rain garden is not guaranteed.

Permissions: (Please initial each line)

The Village is the legal owner of the property located at South Russell Village Park - 1000 Bell Rd, South Russell, OH 44022, and hereby acknowledges and agrees to:

- 1. Give permission to CRWP and its partners to enter South Russell Village Park to advise the Village on an appropriate rain garden location and oversee the installation.
- 2. Give permission to CRWP and its partners to enter South Russell Village Park to install the rain garden on a mutually agreed upon date.
- Give permission to CRWP to access South Russell Village Park for technical advice on maintaining the rain garden, monitoring and educational site visits over the next five (5) years, subject to a mutually agreed-upon time.

 Water to promote plant growth and survival, especially during first two years and during dry spells. Inspect site following rainfall events. Add/replace vegetation in any eroded areas. 	As needed (following construction)

 Inspect inflow area for sediment accumulation. Remove any accumulated sediment and debris. Inspect site for erosion as well as sediment and mulch which has been moved around in the garden. Add/replace vegetation and/or soil in any eroded areas. Inspect rain garden for dead or dying vegetation. Replace vegetation as needed. 	Annually (semi-annually during first year)	
Add mulch for depth of 2-3 inches.	Every 2 to 3 years (if needed)	

- Allow the installation and maintenance of the project to be documented with photographs, as detailed in Exhibit A.
 CRWP and partners may publish photographs and project locations for educational purposes. Photographs of visitors will not be published without written permission.
- 6. Communicate with CRWP on any updates regarding the rain garden after installation, such as volunteer workday requests, photos of the rain garden as it matures, changes made to the planting plan, problems encountered, etc.
- 7. Notify CRWP of property transfer so CRWP may have the opportunity to contact the new owners to educate them about the project. The new owner will be responsible for maintaining the rain garden for the rest of the five-year period.
- 8. CRWP and the Village agree to hold each other harmless for any damage or loss to any person or property that may arise out of any injury caused through any act of any staff member, volunteer, employee office, agent, or participant involved with this project, as detailed in Exhibit A.
