Petition summary and background	Pet and therapy goats are prohibited under South Russell Village Ordinance 618.13 (b)
Action petitioned for	We, the undersigned, are residents of South Russell Village and in that way, we urge South Russell Village Council to act to omit "goats" from Ordinance 618.13 (b) and include them as a permissible animal at a residence (just as a "mini-pig" is allowable) under 618.3 (a). We recognize the underlying regulations have yet to be determined by the South Russell Village Council. Yet we ask them to consider this question on our behalf. Petition summary and background	Pet and therapy goats are prohibited under South Russell Village Ordinance 618.13 (b). Goats meanwhile are not prohibited under the Lake Louise Homeowners Association guidelines. After months of research, to teach their four c responsibility, and assist in the special needs of two of their children (who are homeschooled), pet and therapy goat (named "Biscuit" and "Snickers") were formally purchased by Patrick & Carlene Holtz (residents of Lake Louise at 31 Garden Park Drive) on August 20 th . Within 45 minutes of a Facebook post on August 23 rd to the Lake Louise Internal (asking for feedback by Lake Louise residents), a formal complaint was made to the South Russell Mayor and Building Department. As ordinance 618.13 (b) is a minor misdemeanor and as a sign of good faith, the Holtz family returned and Snickers temporarily to their home at "Feels Like Home Farm" in Kirtland, Ohio on August 24 th . On August 25 th Village Building Department inspected the property.
Action petitioned for	We, the undersigned, are residents of Lake Louise and recognize goats are prohibited in South Russell Village. How Biscuit and Snickers (who for the brief time that they were here) brought our community together. We would ask t South Russell Village Council and by implication the Building Department allow for the return of Biscuit and Snicker would give the South Russell Village Building Department and Council the opportunity to <i>study</i> this question withi residence for a period of time as legislation is considered to amend 618.13 (b). We agree to this pilot study under following circumstances: 1) Biscuit and Snickers sleep indoors and come inside by 9:00pm EST on all days, 2) Bisc Snickers can't come outside before 8:00 am on weekdays and 9:00 am on weekends. 3) Any other conditions offe South Russell Village Council and the Building Department. We appreciate your consideration of this question.
