Petition summary and background	Pet and therapy goats are prohibited under South Russell Village Ordinance 618.13 (b). Goats meanwhile are not prohibited under the Lake Louise Homeowners Association guidelines. After months of research, to teach their four or responsibility, and assist in the special needs of two of their children (who are homeschooled), pet and therapy goat (named "Biscuit" and "Snickers") were formally purchased by Patrick & Carlene Holtz (residents of Lake Louise at 31 Garden Park Drive) on August 20th. Within 45 minutes of a Facebook post on August 23th to the Lake Louise Internal (asking for feedback by Lake Louise residents), a formal complaint was made to the South Russell Mayor and Buildin Department. As ordinance 618.13 (b) is a minor misdemeanor and as a sign of good faith, the Holtz family returned and Snickers temporarily to their home at "Feels Like Home Farm" in Kirtland, Ohio on August 24th. On August 25th Village Building Department inspected the property.
Action petitioned for	We, the undersigned, are residents of Lake Louise and recognize goats are prohibited in South Russell Village. How Biscult and Snickers (who for the brief time that they were here) brought our community together. We would ask to South Russell Village Council and by implication the Building Department allow for the return of Biscult and Snicker would give the South Russell Village Building Department and Council the opportunity to study this question with residence for a period of time as legislation is considered to amend 618.13 (b). We agree to this pilot study under following circumstances: 1) Biscuit and Snickers sleep indoors and come inside by 9:00pm EST on all days, 2) Bisc Snickers can't come outside before 8:00 am on weekdays and 9:00 am on weekends. 3) Any other conditions offer South Russell Village Council and the Building Department.
