WHEREAS, it is the opinion of the Mayor and Council of the Village of South Russell that it is important to commemorate and celebrate the Village of South Russell's centennial with activities that honor the historical significance of the Village, promote the Village's reputation, and are beneficial to the Village residents and commerce.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OFSOUTH RUSSELL, OHIO, THAT:

Section 1. Council of the Village of South Russell hereby supports the following activities planned to commemorate and celebrate the Village's Centennial:

- Grand Marshall of the Blossom Time Parade scheduled for May 28, 2023;
- Village business participation in the Blossom Time Parade scheduled for May 28, 2023;
- 1920's theme band concert scheduled for July 18, 2023;
- Village birthday party scheduled for July 23, 2023;
- Kids movie night scheduled for August 4, 2023;
- Tour of the historic Rarick Cemetery, date to be determined;
- Presentation of the history of the Interurban, date to be determined;
- Inclusion of centennial activities at the Village Fall Festival, date to be determined;
- Booklet of first 100 years in the Village; and
- Questionnaires.

<u>Section 2.</u> The Mayor and Councilman Ruth Cavanagh are hereby authorized to organize and plan the above-listed activities on behalf of the Village, subject to Council approval of the expenses for such activities, which such expenses in total shall not exceed \$10,000.00.

<u>Section 3.</u> That it is found and determined that all formal actions of the Council relating to the adoption of this resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements.

<u>Section 4.</u> This Resolution is hereby declared to be an emergency measure, necessary for the preservation of the public peace, health, welfare and safety of the Village of South Russell and its residents and for the further reason that this Resolution must be immediately effective to

allow such planning and organizing for the soon-occurring activities; wherefore, provided it receives the affirmative vote of at least two-thirds (2/3) of all members elected to Council, this Resolution shall be in full force and effect immediately upon its passage.
