**ORDINANCE AMENDING ORDINANCE NO. 2023-06 ONLY CERTIFYING  
ADVANCE OF \$50,000 FROM THE INCOME TAX FUND TO THE CULVERT  
FUND INSTEAD OF THE TRANSFER OF \$50,000 TO THE CULVERT FUND  
AND DECLARING AN EMERGENCY**

WHEREAS, on January 23, 2023, Council of the Village of South Russell, Geauga County, Ohio passed Ordinance No. 2023-06 certifying the transfer \$50,000 from the Income Tax Fund to the Culvert Fund and certifying the transfer of \$127,687 from the Income Tax Fund to the Special Equipment Fund; and

WHEREAS, after consultation with the Geauga County Auditor's Office, the "transfer" of \$50,000 from the Income Tax Fund to the Culvert Fund was a misnomer, as it was technically an advance of \$50,000 from the Income Tax Fund to the Culvert Fund; and

WHEREAS, Council of the Village of South Russell desires to only amend, in part, Ordinance No. 2023-06 from a "transfer" of \$50,000 from the Income Tax Fund to the Culvert Fund to an advance of \$50,000 from the Income Tax Fund to the Culvert Fund.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of South Russell, Geauga County, Ohio that:

SECTION 1. Section 1 of Ordinance No. 2023-06, attached hereto as Attachment 1, is hereby amended to certify the advance of the sum of \$50,000 (instead of the transfer of \$50,000) as follows:


FROM: INCOME TAX FUND TO: CULVERT FUND \$50,000

SECTION 2. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the health, welfare and safety of the residents of the Village of South Russell and for the further reason that the funds are needed immediately to meet the budgetary obligations of the Village.

SECTION 3. This Ordinance shall take effect and be in full force immediately upon its passage.

SECTION 4. It is hereby found and determined that all formal action of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees on or after December 2, 1975, that resulted in formal action, were in meetings open to the public in compliance with all legal requirements including Section 121.22, Ohio Revised Code.

SECTION 1. The sum of \$ 177,687 is hereby certified to be transferred:

FROM: Income Tax Fund TO: Culvert Fund \$ 50,000  
Special Equipment 127,687

SECTION 2.
