ORDINANCE APPROVING THE PROPOSAL AND ACCEPTANCE AGREEMENT BETWEEN THE VILLAGE OF SOUTH RUSSELL AND HERSHBERGER ROOFING & SIDING LLC IN AN AMOUNT NOT TO EXCEED \$27,120 FOR THE RE-ROOFING OF THE VILLAGE SERVICE DEPARTMENT GARAGE, AUTHORIZING THE MAYOR AND FISCAL OFFICER TO EXECUTE THE AGREEMENT ON BEHALF OF THE VILLAGE, AND DECLARING AN EMERGENCY.

WHEREAS, Council desires to re-roof the Village Service Department garage;

WHEREAS, Hershberger Roofing & Siding LLC, a roofing and siding limited liability company, has provided Council with a proposal and acceptance agreement to re-roof the Village Service Department garage ("Agreement"); and

WHEREAS, Council desires to enter into such Agreement with Hershberger Roofing & Siding LLC.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of South Russell, Geauga County, Ohio that:

SECTION 1. The Agreement between the Village of South Russell and Hershberger Roofing & Siding LLC, attached hereto and incorporated herein by reference as <u>Attachment A</u>, engaging Hershberger Roofing & Siding LLC to perform the work described in the Agreement, including but not limited to the re-roofing of the Village Service Department garage, in an amount not to exceed \$ 27,120, is hereby approved.

SECTION 2. The Mayor and Fiscal Officer are hereby authorized to execute the Agreement on behalf of the Village and are authorized to take all necessary and other action in accordance with Agreement.

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees on or after December 2, 1975, that resulted in formal actions, were in meetings open to the public in compliance with all legal requirements, including Section 121.22, Ohio Revised Code.

SECTION 4. That this Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health and safety of the inhabitants of the Village and for the further reason to enable the Village to have the work completed in a timely manner; wherefore, provided it receives the affirmative vote of at least two-thirds (2/3) of

all members elected to Council, this Ordinance shall be in full force and effect from and immediately upon its passage by this Council and approval by the Mayor.

- Remove existing layers of shingles, gutters and downspouts on upper level service garage roof and remove from jobsite.
- Replace any rotted sheathing @\$60. per 4 x 8 sheet or roof boards @ \$4. per foot.
- Install 2 rows (6 ft.) Certainteed WinterGuard (Ice & water shield) at eaves.
- Use WinterGuard around chimneys, vent pipes, at valleys, side walls, end walls, etc.
- Cover remaining roof area with synthetic felt and install heavy duty drip edge.
- Install shingle-over Owens Corning Ventsure ridge vents on all top ridges (cut vent slots if needed).
- Install new vent pipe flashing, endwall / sidewall flashing, etc.
- · Install (recommended) Owens Corning Tru-Def Duration lifetime dimensional shingles.
- Install new 5" Forrest Green seamless aluminum gutters with hidden fasteners and over-sized (3x4)
 Forrest Green downspouts on service garage roof only. (some colors may be higher cost)
- Remove debris from jobsite.
- Hershberger Roofing & Siding provides a 5 year workmanship warranty on roofing and 10 year on siding and windows. Lower level and low sloped roofs not included in this proposal.
