ORDINANCE APPROVING THE **AGREEMENT** BETWEEN ELECTRIC, INC. AND THE VILLAGE OF SOUTH RUSSELL IN **INSTALLATION** \$2,538.00 **AMOUNT OF FOR OF ELECTRICAL** COMPONENTS FOR SERVICE INCREASE IN CONNECTION WITH THE SOLAR PANEL PROJECT AT THE VILLAGE OF SOUTH RUSSELL POLICE DEPARTMENT, AUTHORIZING THE MAYOR, FISCAL OFFICER, AND/OR POLICE CHIEF TO EXECUTE THE AGREEMENT, AND DECLARING AN EMERGENCY.

WHEREAS, Council desires to engage the services of an electrical company to install additional electrical components for the service increase in connection with the solar panel project at the Village of South Russell Police Department;

WHEREAS, Kenco Electrical, Inc. ("Kenco") is in the business of providing such electrical services and has provided the Village of South Russell with a proposed agreement ("Agreement"), a copy of which is attached hereto and incorporated herein by reference as **Attachment 1**; and

WHEREAS, Council desires to approve such Agreement with Kenco.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of South Russell, Geauga County, Ohio that:

SECTION 1. The Agreement, attached as **Attachment 1**, between Kenco and the Village of South Russell for Kenco's electrical services as described in the Agreement in the amount of \$2,538.00 is hereby approved pursuant to the Agreement's terms and conditions.

SECTION 2. The Mayor, Fiscal Officer and/or the Police Chief are hereby authorized to execute the Agreement on behalf of the Village.

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees on or after December 2, 1975, that resulted in formal actions, were in meetings open to the public in compliance with all legal requirements, including Section 121.22, Ohio Revised Code.

SECTION 4. That this Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health and safety of the inhabitants of the Village and to secure the electrical service to enable the solar panel project to proceed; wherefore, provided it receives the affirmative vote of at least two-thirds (2/3) of all members elected to Council, this Ordinance shall be in full force and effect from and immediately upon its passage by this Council and approval by the Mayor.
