AN ORDINANCE APPROVING THE PAY SCHEDULE FOR EMPLOYEES AND OFFICIALS OF THE VILLAGE OF SOUTH RUSSELL FOR 2025 ONLY, EFFECTIVE JANUARY 1, 2025.

WHEREAS, by Ordinance No. 2022-108, Council of the Village of South Russell repealed the previous pay range schedules for employees and officials of the Village of South Russell;

WHEREAS, pursuant to its statutory authority to establish the organization of its employment positions and department and set the compensation of full-time and part-time employees of the Village of South Russell, by Ordinance No. 2022-108, Council of the Village of South Russell adopted the pay schedule for 2024 for employees and officials of the Village of South Russell; and

WHEREAS, because of the Council of the Village of South Russell recently approving an increase in pay for its employees and officials for 2025, Council of the Village of South Russell desires to approve the pay schedule for 2025 reflecting such increase ("Pay Schedule 2025"), which Pay Schedule 2025 is attached hereto and incorporated herein by reference as <u>Attachment 1</u>.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF SOUTH RUSSELL, GEAUGA COUNTY, STATE OF OHIO:

**SECTION 1.** That Pay Schedule 2025, as attached hereto and incorporated herein by reference as **Attachment 1**, is hereby approved as the pay for employees and officials of the Village of South Russell for the year 2025.

**SECTION 2.** It is hereby found and determined that all formal actions of this Council concerning and relating to passage of this Ordinance were adopted in lawful meetings of this Council and that all deliberations of this Council, and that all deliberations of this Council and of any of its committees on or after December 2, 1975, that resulted in formal actions, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 3**. This Ordinance shall take effect and be in force after the earliest period allowed by law.
