**WHEREAS**, the Village of South Russell has acquired certain personal property that is not needed for public use; and


**WHEREAS**, Council for the Village of South Russell desires to discard or salvage such unneeded personal property as authorized by Section 721.15(C) of the Ohio Revised Code.

**NOW THEREFORE BE IT ORDAINED** by the Council of the Village of South Russell, Geauga County, Ohio, that:

**SECTION 1.** The Village of South Russell hereby determines that the personal property described and set forth in the Inventory List which is attached hereto and incorporated herein by reference as Exhibit A is not needed for public use, has no value, and the Village of South Russell is hereby authorized to discard or salvage such personal property listed on Exhibit A as it deems appropriate.

**SECTION 2.** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees on or after December 2, 1975, that resulted in formal actions, were in meetings open to the public in compliance with all legal requirements, including Section 121.22, Ohio Revised Code.

**SECTION 3.** That this Resolution is declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health and safety of the inhabitants of the Village and for the further reason to allow the Village to immediately discard or salvage its personal property that is unneeded and has no value.
