AN ORDINANCE APPROVING THE SOLID WASTE MANAGEMENT PLAN FOR THE GEAUGA-TRUMBULL SOLID WASTE MANAGEMENT DISTRICT AND DECLARING AN EMERGENCY.

WHEREAS, the Geauga-Trumbull Solid Waste Management District (the "District"), by its Policy Committee, has adopted a Solid Waste Management Plan (the "Plan") for the District; and

WHEREAS, pursuant to Section 3734.55(B) of the Oho Revised Code, the board of county commissioners and the legislative authority of each municipal corporation or township under the jurisdiction of the District, must approve or disapprove the plan by ordinance or resolution; and

WHEREAS, the Village of South Russell in Geauga County, Ohio has reviewed the Plan, considered it a duly called meeting, and has determined that the Plan furthers the public interest.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of South Russell, Geauga County, Ohio that:

<u>SECTION 1.</u> The Plan for the District, adopted by the Solid Waste Policy Committee on April 2, 2025, is hereby approved.

<u>SECTION 2.</u> The Fiscal Officer is hereby directed to cause a copy of this Ordinance to be promptly delivered to the Solid Waste Policy Committee of the Geauga-Trumbull Solid Waste Management District.

<u>SECTION 3.</u> It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees on or after December 2, 1975, that resulted in formal actions, were in meetings open to the public in compliance with all legal requirements, including Section 121.22, Ohio Revised Code.

SECTION 4. This Ordinance is hereby declared to be an emergency measure for the immediate preservation of the public peace, health and safety of the Village of South Russell and to ensure the District receives the approval timely; wherefore, provided it receives two-thirds (2/3) of the votes of all members elected to Council, this Ordinance shall be in full and effect from and immediately upon its passage by this Council and approval by the Mayor; otherwise it shall take effect and be in force after the earliest period allowed by law.
