ORDINANCE APPROVING THE AGREEMENT BETWEEN SIMVAY SYSTEMS LLC AND THE VILLAGE OF SOUTH RUSSELL FOR INFORMATION TECHNOLOGY SERVICES FOR THE VILLAGE'S POLICE DEPARTMENT IN AN AMOUNT NOT TO EXCEED \$4,600, AUTHORIZING THE POLICE CHIEF TO EXECUTE THE AGREEMENT, AND DECLARING AN EMERGENCY.

WHEREAS, Council desires to provide information technology services to the Village's police department for information technology monitoring and management ("IT Services");

WHEREAS, Simvay Systems LLC is in the business of providing such IT Services and has provided the Village of South Russell with a proposed agreement ("Agreement"), a copy of which is attached hereto and incorporated herein by reference as <u>Attachment 1</u>; and

WHEREAS, Council desires to approve such Agreement with Simvay Systems LLC.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of South Russell, Geauga County, Ohio that:

SECTION 1. The Agreement, attached as <u>Attachment 1</u>, between Simvay Systems LLC and the Village of South Russell for IT Services in an amount not to exceed \$4,600 is hereby approved pursuant to the Agreement's terms and conditions.

SECTION 2. The Police Chief is hereby authorized to execute the Agreement on behalf of the Village.

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees on or after December 2, 1975, that resulted in formal actions, were in meetings open to the public in compliance with all legal requirements, including Section 121.22, Ohio Revised Code.

SECTION 4. That this Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health and safety of the inhabitants of the Village and to secure the Agreement as soon as possible; wherefore, provided it receives the affirmative vote of at least two-thirds (2/3) of all members elected to Council, this Ordinance shall be in full force and effect from and immediately upon its passage by this Council and approval by the Mayor.
