AN ORDINANCE APPROVING THE PAY SCHEDULE FOR EMPLOYEES AND OFFICIALS OF THE VILLAGE OF SOUTH RUSSELL FOR 2026 ONLY, EFFECTIVE JANUARY 1, 2026.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF SOUTH RUSSELL, GEAUGA COUNTY, STATE OF OHIO:

SECTION 1. That Pay Schedule 2026, as attached hereto and incorporated herein by reference as <u>Attachment 1</u>, is hereby approved as the pay for employees and officials of the Village of South Russell for the year 2026.

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning and relating to passage of this Ordinance were adopted in lawful meetings of this Council and that all deliberations of this Council, and that all deliberations of this Council and of any of its committees on or after December 2, 1975, that resulted in formal actions, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. This Ordinance shall take effect and be in force after the earliest period allowed by law.
