- Third reading of a Resolution of Appreciation for Dennis M. Galicki.
- Second reading of an ordinance declaring it necessary to levy a tax in excess of the ten mill limitation and declaring an emergency (Road and Bridge renewal).
- Introduce and consider for adoption an ordinance approving the LPA-ODOT-LT Project Agreement between the Village of South Russell and the State of Ohio Department of Transportation for the project PID No. 121808, GEA Bell Road East Paving, LPA Agreement No. 42485 for the described project to resurface Bell Road East (CR-10) from Chillicothe Road South Russell East Corporation line in the Village of South Russell, authorizing the Mayor to execute the agreement on behalf of the Village, and

declaring an emergency.

- Introduce and consider for adoption an ordinance amending Section 235.02 of the Village of South Russell's Codified Ordinances to eliminate the Treasury Investment Board, adopt investment procedures in accordance with the Ohio Revised Code, and declaring an emergency.
- Introduce and consider for adoption an ordinance authorizing participation in the ODOT Road Salt Contract (018-27) awarded in 2026, authorizing the Mayor and Fiscal Officer to execute and submit the agreement, and declaring an emergency.
- Introduce and consider for adoption an ordinance approving the Subgrant Award Agreement between the Ohio Office of Criminal Justice Services and the Village of South Russell for grant funds in the amount of \$15,000 for the Village of South Russell Police Department's body cameras, authorizing the Mayor and Police Chief to execute the agreement on behalf of the Village, and declaring an emergency.
