**ORDINANCE APPROVING THE PERFORMANCE AGREEMENT BETWEEN THE VILLAGE OF SOUTH RUSSELL AND HILLCREST CONCERT BAND FOR THE JULY 14, 2026 CONCERT IN THE AMOUNT NOT TO EXCEED \$700.<sup>00</sup> [400 Honorarium + dinner and nonalcoholic beverages for performers] AND DECLARING AN EMERGENCY.**

WHEREAS, Council desires to retain the Hillcrest Concert Band to perform a concert at the Village of South Russell Park on July 14, 2026;

WHEREAS, Hillcrest Concert Band has provided to Council its performance agreement for such concert; and


WHEREAS, Council desires to approve the aforementioned Performance Agreement with Hillcrest Concert Band.

NOW THEREFORE, BE IT ORDAINED by the Council of the Village of South Russell, Geauga County, Ohio, that:

SECTION 1: The Performance Agreement with Hillcrest Concert Band to perform the concert on July 14, 2026 at the Village of South Russell Park in the amount not to exceed \$XXXX, which amount includes the \$400 honorarium and dinner and nonalcoholic beverages for the performers, which Performance Agreement is attached hereto and incorporated herein by reference as **Attachment 1**, is hereby approved.

SECTION 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees on or after December 2, 1975, that resulted in formal action, were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 3: That this Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health and safety of the inhabitants of the Village and for the further reason to enable the Village to secure the band for the concert; wherefore, provided it receives the affirmative vote of at least two-thirds (2/3) of all members elected to Council, this Ordinance shall be in full force and effect from and immediately upon its passage by this Council.

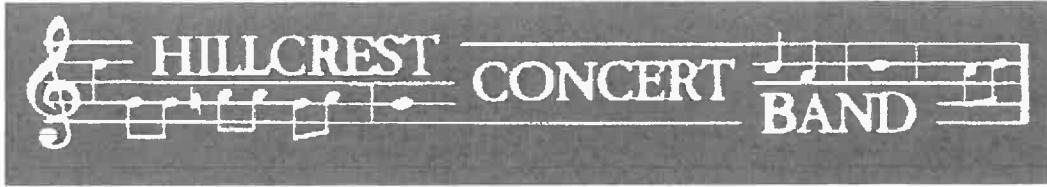
