A RESOLUTION OF APPRECIATION FOR DENNIS M. GALICKI

WHEREAS, Dennis Galicki was elected to serve the Village as a member of Council for two terms commencing from 2018 and concluding in 2025; and

WHEREAS, during his time with Council, Dennis M. Galicki served as both a member and Chairman of the Finance, Human Resources, Properties, Parks, Public Utilities, Safety, and Streets Committees and as a member of the ad hoc Emergency Operations Planning Committee. Additionally, he served as Council's representative to the Planning Commission from 2019 to 2021.

WHEREAS, in the discharge of his duties, Dennis M. Galicki was instrumental in the development of consistent job descriptions and pay ranges for all employees, supported the creation of the playground in the South Russell Village Park, pressed continuously for a strategic plan for the Village to ensure orderly and equitable planning for the community, and focused on financial practices that benefitted all residents with Village projects and the expenditure of taxpayer dollars. He emphasized the importance of good government, and strived for transparency, integrity, and adherence to the Village's directives, policies, and procedures which he participated in establishing; and

WHEREAS, Dennis M. Galicki in his capacity as a Council member acted in a professional, conscientious and dedicated manner, carrying out his duties in an exemplary fashion in the highest traditions of public service.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of South Russell, County of Geauga, State of Ohio, that:

SECTION 1. The Mayor and Council of the Village of South Russell, Ohio express their sincere appreciation to Dennis M. Galicki for service as a Village Council Member and for his dedication to the community.

SECTION 2. The Mayor and Council desire this commendation of Dennis M. Galicki to become a permanent part of the records of the Village of South Russell.

SECTION 3. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees on or after November 25, 1975, that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. This Resolution shall be effective at the earliest time allowed by law.
