- Third reading of an ordinance declaring it necessary to levy a tax in excess of the ten mill limitation and declaring an emergency.
- Introduce and consider for adoption an ordinance amending Section 1024.09 of the Village of South Russell's Codified Ordinances to provide for the inspection and cleaning of septic systems within the Village to be administered through Geauga Public Health's Operation and Maintenance Program, and declaring an emergency.

- Introduce and consider for adoption an ordinance amending Cemetery Fund increasing expenses \$5,000; General Fund increasing other expenses \$41,200; Street Maintenance Fund increasing expenses \$270,000; Safety Fund increasing other expenses \$4,520; Park Fund increasing expenses \$8,000; Income Tax Fund increasing expenses \$271,000; and Bell Road East Fund *decreasing* expenses \$1,000,000, and declaring an emergency.
- Introduce and consider for adoption an ordinance transferring \$270,000 from the Income Tax Fund to the Street Maintenance Fund and \$1,000 to the Park Fund, and declaring an emergency.
- Introduce and consider for adoption an ordinance de-certify \$1,000,000 in grant revenue for Bell Road East, and declaring an emergency.
- Introduce and consider for adoption an ordinance certifying \$100,000 in additional Income Tax revenue, and declaring an emergency.

(2) Oral communications. Any person or his authorized representatives who wishes to address Council should notify the Fiscal Officer by noon on the Thursday before the scheduled meeting to be included on the agenda. During the visitors section, any person or his authorized representatives may appear before Council on any matter of Village business at the proper time provided in the agenda by rising and securing permission of the Presiding Officer. Such person shall state in an audible tone of voice for the record his name and address and the name and address of the person or group he may represent, if other than himself. Such person shall limit his address to five minutes unless the Presiding Officer or Council grants further time. No person other than the members of Council and the person having the floor shall be permitted to enter into any discussion, either directly or through a member of Council, without the permission of the Presiding Officer. No question shall be asked of a member of Council except through the Presiding Officer.
